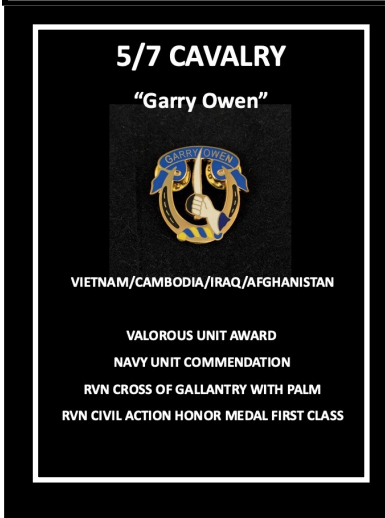

5/7 Squadron Update

Fellow WARPAINT Family and Friends and Troopers, both Past and Present,

I write now at the end of a period of rapid change within the world and inside of our own organization. Only 8 months ago we redeployed from Korea with the promise of predictability. But those who live in the saddle understand that this world often has other plans and that the Squadron will always be called upon to meet those unforeseen challenges first.

Due to our "readiness posture", our brigade (1st Brigade, 3rd ID) was recently assigned a mission of Immediate Response Force (IRF), which dictates the unit to temporarily assume a "heightened readiness/preparedness posture" in order to be called upon for mission with little or no notice. Examples of these missions are: the evacuation in Afghanistan last fall, Ebola Response, COVID support, Capitol Riots on Jan 6, 2021, natural disasters, and other potential real world requirements like the one currently unfolding in Europe. These types of missions are more familiar to Infantry Brigade Combat Teams (IBCT) such as those located in Fort Bragg, NC and Fort Campbell, KY because IBCT's have less equipment and personnel and have a mission set that is much easier to "rapidly deploy". ABCT's (Armor Brigade Combat Teams), however, are much more complicated to rapidly deploy and conduct these types of mission sets far less frequently than IBCT's. And so it is with the Squadron by my side that I write to you from Germany now.

You should be incredibly proud of the Squadron as very few units can say they have operated on three different continents within the span of 8 months. In my 19 years of service I have never seen an ABCT deployed with such aggressiveness and speed. Your Troopers were chosen to lead the BDE into theater and will be amongst the first to begin training in Germany. I promise to keep you updated as time permits but wanted to pass along our gratefulness at the tremendous support you continue to show us.

Chaplain's Corner

"Another Memorial Day is right around the corner. Since November 2004, it has been an honor to text, email, and talk by phone with many of the 5th Squadron 7th Cavalry Troopers who are either checking in or struggling during this important time of Remembrance in memoriam. Having also had the honor of memorializing all our Fallen from that time to the present that died in combat operations and even between deployments, it is a sobering time for me as well even all these years later. I think of our elder Troopers who served in Vietnam over 55 years ago and the 55 Memorial Days since then.

My personal tradition during this time and as I transition out of Active Duty is to visit a local Veterans Cemetery near where I live. I usually arrive very early and walk the grounds and pick up trash along the way. Later, I attend the Ceremony that is held there and sometimes I am called upon to provide Invocations and Benedictions. In the evening, I go to the beach here on the North Shore of Oahu in Hawaii and watch the sunset. I watch the sunsets that our Fallen no longer have the opportunity to watch and read passages of scripture. There is a restaurant near the place where I watch the sunset and I have dinner and drink a glass of wine or two in their honor.

As a Christian minister, I honor them in my ways and continue to make myself available to those who served with them and their family members. From our first losses in Iraq in February 2005, to those we lost in Afghanistan in 2013, it is critical we never forget our Fallen and just as importantly we find healthy and creative ways to honor their sacrifice. As your Associational Chaplain, one way we can continue this tradition is by befriending and talking with our elder Troopers. If you have not done so already, reach out and befriend at least one Cav Scout from the Vietnam era. To further honor our Fallen and while at the same time having a healthy way to keep yourself accountable, I want to encourage each of you to become a member of your local DAV, VFW, and local Veterans groups. We must carry the mantle to the next generation of Cavalry Troopers and do so honorably. Layered accountability is a tried and proven method. Be available for others, honor our Fallen, and be accountable for yourself in the process."

VA Information

Dear Veteran,

You may be eligible for newly enacted service-connected benefits.

Over the course of the last six months, the Department of Veterans Affairs (VA) has begun processing service-connected disability claims for six new presumptive conditions related to environmental exposures during military service. We request your help in making more Veterans aware of these newly added presumptive conditions to help them file a claim and obtain any earned benefits.

In May 2021, VA started implementing provisions of the William M. Thornberry National Defense Authorization Act for Fiscal Year 2021 (NDAA), adding bladder cancer, hypothyroidism and Parkinsonism to the list of medical conditions presumptively associated with exposure to Agent Orange. A few months later VA added asthma, rhinitis and sinusitis (to include rhinosinusitis) on a presumptive basis based on particulate matter exposures during military service in Southwest Asia and certain other areas.

Any Veteran who was previously denied service-connection for any of these six conditions but had symptoms manifest within 10 years of military service would need to file a supplemental claim. Be sure to use VA Form 20-0995, Decision Review Request: Supplemental Claim when filing. The claim form should include the name of the condition and specify that the condition is being claimed due to in-service exposure to environmental hazards.

VA is committed to assisting Veterans who may have been exposed to hazardous materials during their military service.

Be sure to stay plugged in to www.va.gov for the most recent developments around environmental exposures during military service, as VA is constantly conducting research and surveillance as well as reviewing scientific literature for conditions that may be related to exposure during military service.

Financial Report by Dick Baker

Our cash balance is \$101,976 compared to \$76,689 at the end of our last reunion and \$88,686 at the beginning of the year. The increase is primarily from additional reunion registrations and dues payments. Our cash balance now includes \$22,773 for the upcoming reunion.

Since the upcoming reunion is more expensive than Hot Springs, you can mail the cost difference to my address below. If you have questions on the amount, please call my cell # 603-455-1047. If you prefer, you can also pay when registering at the reunion. Note that I am now in Arizona but return to New Hampshire in April. The Post Office has had a few problems forwarding mail this year. So, if you send a check and it has not cleared your bank, call to let me know.

As you know, our main hotel (Embassy Suites) is now booked and a second hotel for our overflow has been obtained. Call the Homewood Suites now to book your room. (615-465-0400) We also have members who have reserved a room at the Embassy Suites, but not registered with me. Please send me your registration sooner than later.
