After you get these back make a copy and send one to the Cav 5/7 Association so we can continue searching for your buddies.

### HEALTH TIP FOR YOUR HEART

#### AND THE BEAT GOES ON First Aid in the case of Heart Attack

Let's say it's 6:15 p.m. and you're driving home (alone of course), after an unusually hard day. You're really tired, upset and frustrated. Suddenly, you start experiencing severe pain in your chest that starts to radiate out into your arm and up into your jaw. You are only about five miles from the hospital nearest your home; unfortunately you don't know if you'll be able to make it that far.

What can you do? You've been trained in CPR but the guy that taught the course neglected to tell you how to perform it on yourself.

Since many people are alone when they suffer a heart attack, this article seemed to be in order. Without help, the person whose heart stops beating properly and who begins to feel faint, has only about 10 seconds left before losing consciousness. However, these victims can help themselves by coughing repeatedly and very vigorously. A deep breath should be taken before each cough. The cough must be deep and prolonged, as when producing sputum from inside the chest. And a cough must be repeated about every 2 seconds without let up until help arrives, or until the heart is felt to be beating normally again. Deep breaths get oxygen into the lungs and coughing movements squeeze the heart and keep the blood circulating. The squeezing pressure on the heart also helps it regain normal rhythm. In this way, heart victims can get to a hospital.

Tell as many other people as possible about this, it could save their lives!

### **Combat Related Special Compensation**

DoD has implemented Combat Related Special Compensation for Certain Military Retirees. The CRSC program will benefit disabled retirees who have 20 or more years of active duty service in the military and who fall into one of two categories:

1. Retirees wounded in combat and who received the Purple Heart for an injury that is rated 10% or higher

2. Retirees severely disabled in combat-related incidents that receive a 60% or higher disability rating for illnesses, injuries incurred in combat, combat-related training, or hazardous duty pay. - Special Compensation will be non-taxable .

- VA Disability codes will be used in the evaluation process and VA's presumptive illnesses will apply.

Let me bring you up to speed on our database. We have about 4,100 names now of people who at one time or another were a part of the  $5^{\text{th}}$  of the  $7^{\text{th}}$ . We have found about 50%and still don't know the whereabouts of 50%. It breaks down this way: 1,374 names of people who have good addresses, 239 who we found but now have bad addresses, 300 KIA's, 185 deceased since we have returned, and 1,969 troopers we haven't located. I don't think there is another outfit of similar size that served in Vietnam that can boast about finding almost half of those assigned to it during its time in country.

So much has gone on with the Veterans Affairs! Especially with those have retired after 20 yrs, and have disability. I won't go into specific details as that area belongs to VSO's in the service organizations and the VA VSO. S/Maj Westmoreland should be given a large THANK YOU for assisting so many others for this endeavor.

I have stated time and time again certain steps to the disability award. One, I had to dig for myself was, the board action for the Purple Heart. I have kept the award itself, and my 1st board action pertaining to it. When I called the VA regional office they couldn't find it at all!! Then the DAV regional office came up with same answer. Needless to say I was frustrated. As I was prepared I sent my paper work in anyway, and I FAXED copies to the VA/DAV. The faxed documents showed them that they had retired files that shouldn't have been. Remember to KEEP ALL documentation pertaining to your service SAFE GUARDED, not only for your use, but also for your survivors so they will receive the proper benefits.

Also, I have received complaints about the VA hospital debiting the private insurance companies. Yes, they can IF the treatment (not just medication) is not service connected and VA board action certified it. You must apply for service connection. Another sore spot has been the priority 1-8 system. Those in categories 1-3 are becoming upset that they have to wait in long lines because of the other cat's flooding the system. First of all it is NOT the fault of those working in the VA hospitals. And the anger I have seen is uncalled for. They are doing the job that they have been told to do. Any complaints should be in written form to the VA RE-GIONAL office and your representatives. They make the regulations.

Soon, we'll have another reunion. This time I hope to stay the whole time, God willing.


